It can lead to patients better understanding the appropriate treatment and care needed. In this hands-on program, you will get to experience the role of the patient and the doctor, expanding both your technical and behavioral skills in splint therapy. You will learn how to use the anatomic appliance to achieve predictability and longevity in your patient's dentition and your restorative dentistry.

- Provide another tool in your "bite splint toolbox" for individualized differential diagnosis and treatment of TMD and OMD (occlusal-muscle dysfunction).

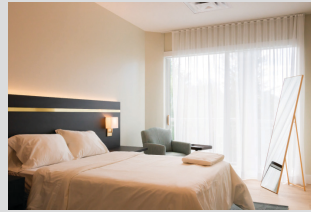
